Update 22: April 13, 2020

Good afternoon,

Today Governor Phil Murphy joined Governor Cuomo and the governors of CT, PA, DE and RI via teleconference to announce a regional advisory council to guide the reopening of our regional economy after the #COVID19 emergency has passed. Each state will have three representatives on the advisory council: governor's chief of staff, health department official, and economic development official. It is possible that other states will participate, as Governor Cuomo openly invited other states to join. Cuomo expects the reopening process to begin within weeks for New York and hopes that any efforts by NJ or other states complements the strategy developed by this council.

At today's NJ COVID-19 Taskforce Update, Governor Murphy announced that he signed <u>Executive Order 126</u> prohibiting cable and telecommunications providers from terminating internet and voice service.

Over the weekend, Governor Murphy signed <u>Executive Order 125</u>, imposing additional mitigation requirements on NJ TRANSIT and all private carriers to limit the spread of COVID-19. The order also outlines specific policies on restaurants that have remained open for takeout orders.

NEWARK NJ: BE STILL MONDAYS," ENCOURAGING FULL CITY "SHUT DOWN" TO COMBAT COVID-19 SPREAD

Over the weekend, Mayor Ras J. Baraka announced "Be Still Mondays" encouraging "everyone to stay home" for a nearly complete shut-down of the City of Newark on Mondays to bring attention to the severity of the COVID-19 spread in the community and help slow the spread. Beginning today, April 13, "Be Still Mondays" will happen each week for the next month. The City would like businesses deemed "essential" by prior executive orders, such as food stores and pharmacies, to also close, as well as downtown corporations and manufacturing companies; however, this is a request by the local government and not a mandatory order. "STAY AT HOME" EXECUTIVE ORDER 107 STILL IN PLACE

The "Stay at Home" <u>Executive Order No. 107</u> remains in full effect with additional requirements as stated in EO 122.

Employees reporting to work are permitted to travel to and from their place of business. Businesses are encouraged to give each employee a letter indicating that the employee works in an industry permitted to continue operations, and their shift. Essential employees should have the company letter, and company ID accessible while driving to and from work, so they can present it with their license if necessary. We suggest the <u>DHS Guidance to help</u> with the letter.




