## **CCNJ BOARD OF TRUSTEES APPOINTS HOLLENDER AND MCCABE AS NEW ASSOCIATE MEMBER REPRESENTATIVES**

**TRENTON, NJ - (Aug. 7, 2024)** – At its recent meeting, the Chemistry Council of New Jersey (CCNJ) Board of Trustees unanimously appointed Rebecca Hollender, Practice Leader with TRC, and Carol McCabe, Managing Partner of Manko, Gold, Katcher & Fox, to serve a two-year term on the Board as representatives of our Associate Member companies starting in September 2024.

Membership on CCNJ's Board of Trustees was initially limited to Regular Member companies (chemistry industry manufacturers). In 2019, the by-laws were updated to include two representatives from Associate Member companies (service providers like law firms and engineering firms) for a two-year term.
