Legislative

- **216th Legislative Session (2014-2015):** Out of **8840** bills introduced by the Legislature, CCNJ tracked more than **327** of them.
- CCNJ Supported 76 bills, opposed 99 bills, and monitored 185 bills.
- **CCNJ Supported Bill A-3083** (*Microbeads Bill: Prohibits manufacture, sale or promotion of personal care products containing microbeads*) <u>signed by Governor Christie</u>. CCNJ was instrumental in ensuring that chemistry industry amendments were included in the final bill.
- **CCNJ Supported Bill A-2477** (*Biosimilar Bill: Establishes requirements for pharmacists to dispense biological products*) <u>signed by Governor Christie</u>. CCNJ worked tirelessly to ensure passage .
- ACR-239/SCR-133: CCNJ was successful in its efforts to get two bipartisan resolutions, which promote and support the Safe and Accurate Food Labeling Act of 2015.
- A-4344/S3183: CCNJ worked with legislators to introduce A-4344/ S3183, which criminalizes using drones to conduct surveillance of or fly over critical infrastructures, and requires certain drones to be registered and insured.

Regulatory

- The Council engaged New Jersey Department of Environmental Protection regulators in an effort to drive reforms to improve three key areas: **site remediation**, **water quality** and **permitting**, and the **air program**.
- Partnered with NJDEP to offer training to 100 site remediation professionals.
- CCNJ continues to advocate for greater transparency related to standards setting and chemical risk assessments, particularly through the Drinking Water Quality Institute (DWQI).

Security, Health & Safety

- Coordinated 3 different rail safety table top exercises in South and Central Jersey with CCNJ members, emergency responders, Conrail, and related regulatory agencies.
- Promoted TRANSCAER[®] North East Tour in New Jersey, which more than 300 people participated in training in Westville, NJ, and Newark, NJ.

Energy

- CCNJ continues to help keep the lights on, and energy prices down with its unique Energy Aggregation program. Collectively, participating companies have saved more than \$100 million on energy costs or about \$166,666 on average per year for the last 16 years.
- In 2015, CCNJ expanded its program to include natural gas procurement, and many participants have already started to save on their natural gas costs this winter.
